The TREASURER'S REPORT

Chadd Kuhn provided the chapter's financial statement dated 3 March 2023. Total cash in the bank is \$37,109.43.

Tom McGrath and Chadd opened two new accounts at Chase Bank; one for the Chapter and one for the Ohio Green Beret Support Group, our charitable organization. Debit cards for the use of Chadd and Tom are being mailed to them by Chase. Chadd will also link the chapter's Stripe account to these two bank accounts: one for collecting chapter

MEETING DISCUSSION AND ACTION ITEMS (leads for actions noted in bold)

-Meeting agenda was outlined by **Patrick Enlow**. Discussion items follow:

NEW BUSINESS:

1. **Larry Verne** shared a video during the meeting at Cincinnati. The video was cleverly transferred from a VHS tape to DVD to thumb drive by a friend of the chapter. The video was a local television news story that was essentially a ten minute documentary of Company C, 2nd Battalion, 11th Special Forces Group's winter warfare training at Fort McCoy, Wisconsin back in 1981. The story includes the airborne operation into Fort McCoy and follows the teams as they conduct survival training and assault training. Open Action Items:

1. **Patrick Enlow** suggested we change our email distribution lists to Mail Chimp. Open action for **Mark Arnold**.
2. Sponsor Drive.
Eric Stansifer suggested and volunteered to develop a concept for a fundraising event that includes a celebrity guest speaker. These are complex events and would be a large step for the Ohio Green Beret Support Group. This would be an event similar to what The Green Beret Foundation has done in the Cincinnati area.
3. **Tom McGrath** and Philip Taraska reported in January that the chapter has been charged with a \$4600 invoice from the project manager of the Crabtree Memorial Monument. The chapter is contesting this entire amount and Tom mailed an official letter to this company to deny payment. The chapter already paid the contracted sum of \$5000 to this company, and the owner claims additional expenses were incurred. These expenses were outside the description and limits of the agreement with this company.
4. **Tom McGrath** will establish a new PO Box for the chapter.

Lunch cost at AMVETS 89 is paid by the chapter, and the Post committed to preparing and serving this for us monthly.

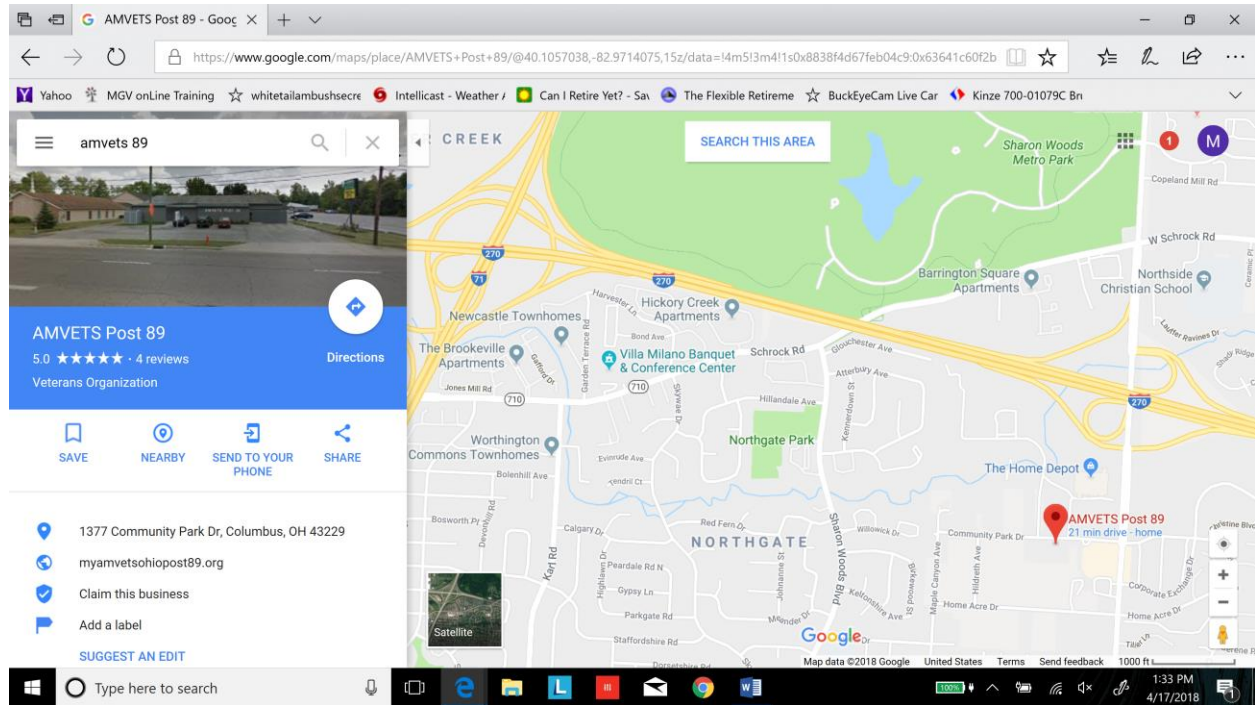

We have three annual \$1000 grants of tuition assistance for chapter members and their immediate family.

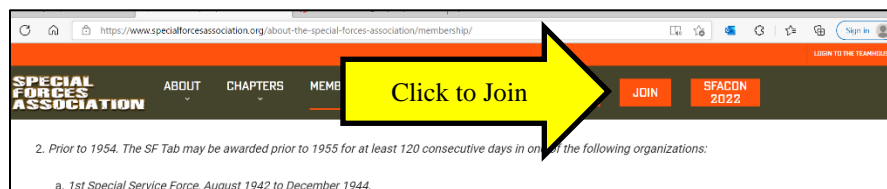

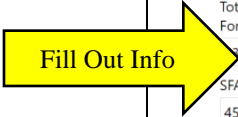

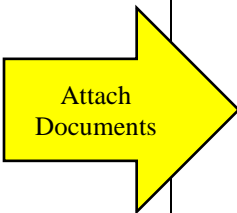

SCHOLARSHIP PROGRAM. This is our primary program for our fund raising which includes two-to-four annual \$1,000 grants of tuition assistance for chapter members and their immediate family.

SF Gold Star Family: The family of SFC Dan Crabtree, KIA Iraq 2005 is our family for the SFA Convention in 2019. SFC Crabtree, 31, was a Special Forces weapons sergeant assigned to the Ohio Army National Guard's Company B, 2nd Battalion, 19th Special Forces Group (Airborne) in Columbus, Ohio. He died June 8, 2006, in Iraq after a roadside bomb exploded next to his vehicle during a combat patrol. In civilian life, Crabtree worked as a police officer first in his native hometown of Hartsville, and then as a member of the Cuyahoga Falls Police Department Special Weapons and Tactics, or SWAT, unit.

Support to families of wounded Green Berets: We pay for all expenses of the unit's annual Christmas party including gifts for the children of Green Berets. We also provide support for the expenses of the unit's family days and awards parties and we support nominations of qualified Green Berets into the Ohio Military Hall of Fame for Valor and make donations to that organization.
