MEETING DISCUSSION AND ACTION ITEMS (leads for actions noted in bold)

-Meeting agenda was outlined by Patrick Enlow. Discussion items follow:

NEW BUSINESS:

1. American Legion Membership.

Member **Rick LaValley** from Portsmouth briefed the chapter about fund raising, through the American Legion:

111 posts in a 50 mile radius of Columbus, received a list.

\$6,000 a year from Portsmouth

You can be a member of the American Legion if you are still in the military.

Sign up at your local post rather than online.

Get on the board and help make charity decisions.

American Legion also has motorcycle riders.

Bottom Line: Join an American Legion Post (at the Post, not online), become a leader, and over time...request the Post make an annual (monthly) charitable donation to The Ohio Green Beret Support Group.

7. Green Beret for a Day fundraiser.

John Stahl was asked to talk about how The Legion Fund raises money for 5th SF Group members and families via The Legion Fund's "Green Beret for a day" fundraiser at Ft. Campbell.

John talked about how The Legion Fund's leaders brought donors/sponsors to Ft. Campbell; 5th SFG Soldiers provided a briefing about the current status of SF. Then they would take them to a range to shoot, observe an airborne operation, tour of a rigger shed, showed them a static display of SF equipment, and mingle with the SF soldiers for about a 7-8 hour day. The 5th SFG could not do this for donors only; all civilians were invited.

Just over 50 people from the greater Nashville area attended.

Revenue: Is unknown.

With the funds they contribute to student scholarships for 5th Group families, give to gold star families, and other needs like paying for a plane ticket to visit injured SF Soldiers.

5th group doesn't collect money; it is managed by a lawyer member of The Legion Fund.

The members discussed what the Ohio National Guard could potentially do to help us execute a similar fundraising event.

Chadd mentioned he is bringing board members from the Green Beret Foundation for an "Open House" at the unit and an airborne operation for the board members to observe. Scheduled for May, possibly July. Just a static display. No shooting, or rappelling, or other events of that nature.

What are some events that you think that Bravo Co could put on for this?

See a prejump briefing, a jump, a helicopter fly-by/static viewing, meet SF Soldiers on the ground after the jump.

Chadd brought up that Rickenbacker may be tough to use because of time limits by the port authority.

John also mentioned The Legion Fund hosted speaking engagements and would invite corporate personnel. This was successful when the movie the 12 Horseman was popular. Retired 5th Group NCOs participated and talked about their tours in Afghanistan.

A night at a Nashville microbrewery with tasting and SF speakers netted approximately \$30,000 in fundraising for The Legion Fund.

Bottom Line: The concept of planning and executing a Green Beret for a Day fundraising event or Speaking event fundraiser needs a leader from the Chapter to champion this and create a plan.



Fund-raising purposes: Funds will be used to support chapter members, members of B/2/19, and other Green Berets who call Ohio their home to support their family when specific circumstances inhibit Green Berets from supporting their family alone.

11. SCHOLARSHIP PROGRAM. Nothing new to report.

This is our primary program for our fund raising. It will be two to four annual \$1000 grants of tuition assistance for chapter members and their immediate family. Definition follows: Chapter member, spouse, or direct lineal descendent of the chapter member; or be a legally adopted dependent or acknowledged by The Defense Enrollment Eligibility Reporting System (DEERS) as a dependent of the chapter member. Tuition grant programs are normally for a four-year degree, but the chapter voted unanimously that the program may include tuition assistance for private or public learning institutions other than a university and other than a bachelors degree; this includes vocational training.

12. <u>SFA 45 will support an SF Gold Star Family</u>. Nothing new to report. The family of SFC Dan Crabtree, KIA Iraq 2005 is our family for the SFA Convention 2019. **Kevin Colwell** volunteered to be the action officer for this initiative.
