The TREASURER'S REPORT

**NEW BUSINESS:**

**1. Ohio Green Beret Support Group Scholarship Program.**

The Columbus Foundation's Scholarship Board selected one recipient for the April 2023 applications. Permelia Belford was selected.

The Fund has two more \$1000 scholarships available for applicants with a deadline of 1 October 2023.

**Open Action Items:**

1. **Tom McGrath** reported via phone that the chapter has not been contested by the chapter's rejection of the extra charges of \$4600 invoice from the project manager of the Crabtree Memorial Monument. There has been no response from the plaintiff regarding a letter Tom mailed to him rejecting the claim.

3. **Patrick Enlow** is adding a Sales page to the SFA45 website.

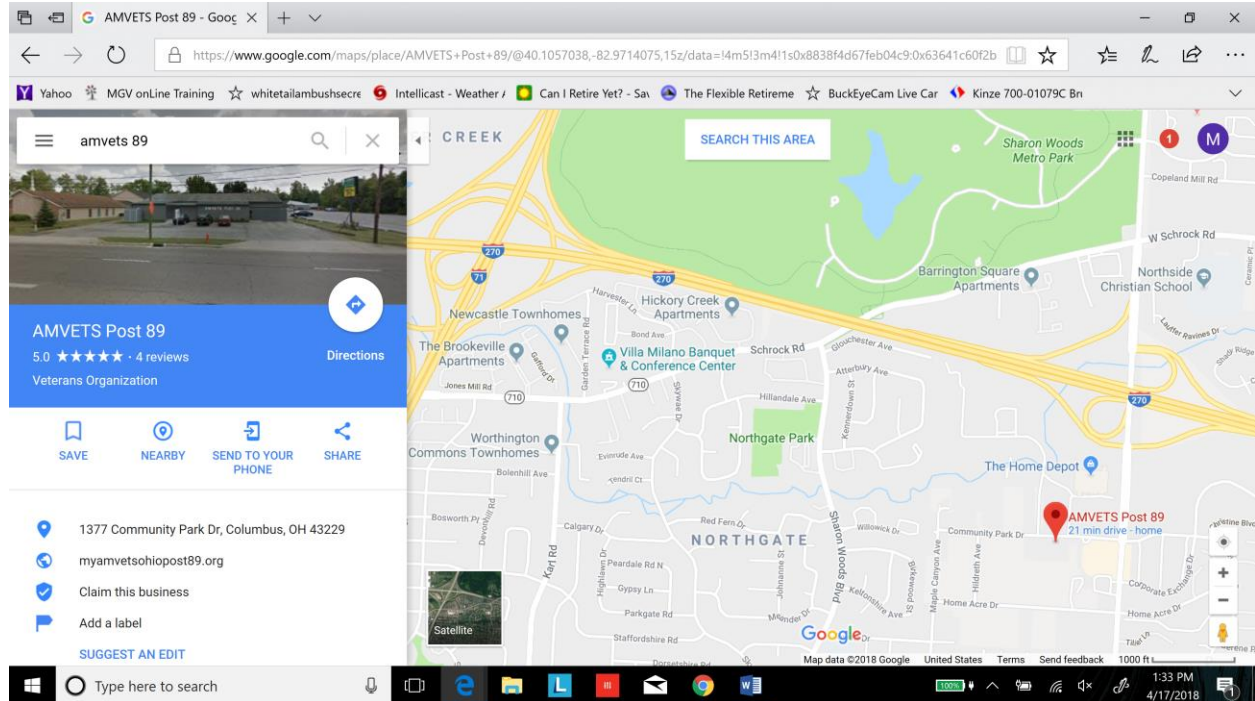

We have three annual \$1000 grants of tuition assistance for chapter members and their immediate family.

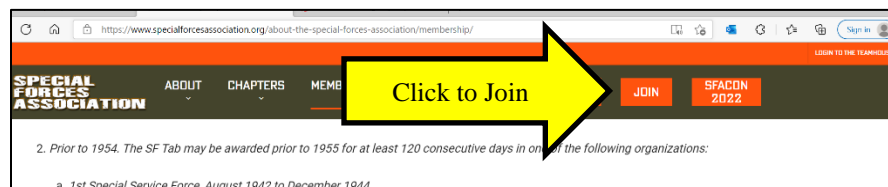

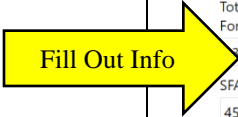

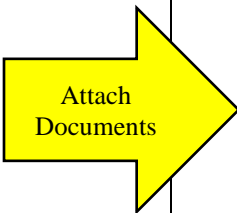

**SCHOLARSHIP PROGRAM.** This is our primary program for our fund raising which includes two-to-four annual \$1,000 grants of tuition assistance for chapter members and their immediate family.

**SF Gold Star Family:** The family of SFC Dan Crabtree, KIA Iraq 2005 is our family for the SFA Convention in 2019. SFC Crabtree, 31, was a Special Forces weapons sergeant assigned to the Ohio Army National Guard's Company B, 2nd Battalion, 19th Special Forces Group (Airborne) in Columbus, Ohio. He died June 8, 2006, in Iraq after a roadside bomb exploded next to his vehicle during a combat patrol. In civilian life, Crabtree worked as a police officer first in his native hometown of Hartsville, and then as a member of the Cuyahoga Falls Police Department Special Weapons and Tactics, or SWAT, unit.

**Support to families of wounded Green Berets:** We pay for all expenses of the unit's annual Christmas party including gifts for the children of Green Berets. We also provide support for the expenses of the unit's family days and awards parties and we support nominations of qualified Green Berets into the Ohio Military Hall of Fame for Valor and make donations to that organization.
