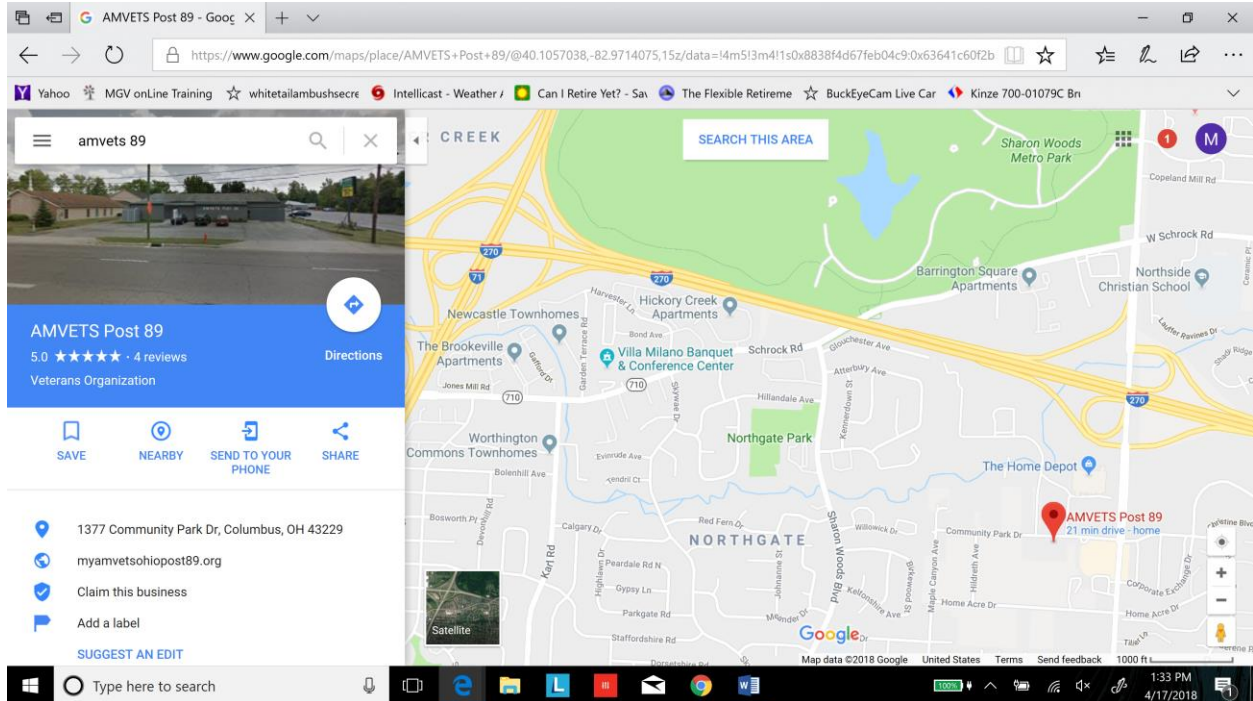
Both are fun events, and the chapter will hold brief meetings during our luncheons.

11. CHAPTER FUNDRAISING

The IRS issued its final approval of The Ohio Green Beret Support Group, LLC (**OGBSG**), a 501(c)(3) Charitable subsidiary organization to Chapter 45.

Its Federal Tax Identification number is: 83-1512941.

Donations should be made payable to **The Ohio Green Beret Support Group, LLC**. All donations to this are entirely tax deductible.

Tom McGrath is researching costs and sources for Director and Officer insurance. John Gonzalez has one suggested firm.

Tom McGrath will establish and manage a Minutes Book for the OGBSG.

Chadd Kuhn and Tom McGrath will submit tax returns for 2017 through 2019 to the IRS by 15 December.

Three civilian executives to be named.

- Committees must be established. Any chapter member and appointed non-chapter members can serve on Committees.
- All chapter members may vote on initiatives for the OGBSG.
- **Mark Arnold** and **Tom McGrath** will recruit three central Ohio executives to serve as the non-chapter member Directors.

Fund-raising purposes: Other than a scholarship program, funds will be used to support chapter members, members of B/2/19, and other Green Berets who call Ohio their home to support their family when specific circumstances inhibit Green Berets from supporting their family alone.

12. SCHOLARSHIP PROGRAM.

This is our primary program for our fund raising. We will begin year 2020 with three annual \$1000 grants of tuition assistance for chapter members and their immediate family. Definition follows:

Candidates must be members in good standing of the Special Forces Association, Chapter 45 (Buckeye Chapter), or theirs spouse, children (including adopted children and stepchildren), and other dependents are also eligible. Other dependents include grandchildren, nieces, nephews, or others for whom the Member is acting in the role of parent or guardian. Candidates must be graduating high school seniors or high school

graduates with a minimum 2.5 grade point average. Candidates must attend a two- or four-year college or university; a career or technical program; post-secondary trade certification program; or a Master's or Doctorate degree at an accredited institution in the U.S.

The Scholarship Program will be managed by The Columbus Foundation. Applicants will find a description of the program on the SFA 45 website. This site will have a link that leads the applicant to this program's location at the Columbus Foundation's website.

The application process will include writing an essay and completing an application form.

The Columbus Foundation will send a list of applicants to SFA 45 to assure they are chapter members in good standing or related to a member as described above.

The Columbus Foundation has a committee that reviews all application submissions and essays, and they choose the awardees. This process will probably occur in late April or May. Both awardees and non-selects will be notified by The Columbus Foundation.

The Chapter voted unanimously to commit \$75,000 of The Green Beret Support Group's funds to establish the endowment for the Program. These funds will be managed by The Columbus Foundation's investment committee. The chapter can discontinue the program and retrieve its funds at any time. The Chapter will set its goal to raise this endowment to \$100,000 by the end of 2020; this will enable funding of two \$2000 or four \$1000 scholarships.

The Program will launch in January of 2020. Look for the Program's description and link at SFA45.org by the second week of January.

SCHOLARSHIP PROGRAM. This is our primary program for our fund raising which includes two-to-four annual \$1,000 grants of tuition assistance for chapter members and their immediate family.

SF Gold Star Family: The family of SFC Dan Crabtree, KIA Iraq 2005 is our family for the SFA Convention in 2019. SFC Crabtree, 31, was a Special Forces weapons sergeant assigned to the Ohio Army National Guard's Company B, 2nd Battalion, 19th Special Forces Group (Airborne) in Columbus, Ohio. He died June 8, 2006, in Iraq after a roadside bomb exploded next to his vehicle during a combat patrol. In civilian life, Crabtree worked as a police officer first in his native hometown of Hartsville, and then as a member of the Cuyahoga Falls Police Department Special Weapons and Tactics, or SWAT, unit.

Support to families of wounded Green Berets: We pay for all expenses of the unit's annual Christmas party including gifts for the children of Green Berets. We also provide support for the expenses of the unit's family days and awards parties and we support nominations of qualified Green Berets into the Ohio Military Hall of Fame for Valor and make donations to that organization.
